# **OUTREACH ACTIVITIES**

In September 2020, Blackleggs Creek Watershed Association received notice that they were awarded a WCAP grant for this round. Blackleggs had neglected to complete their 2019 taxes during the pandemic, so in November, I began collecting the bank statements and compiling it all for the accountant. In December, I finished compiling all financial information for the accountant. In January 2021, Blackleggs received notice from PA DEP that they were awarded a Growing Greener Grant, which is matched by the WCAP grant. I completed all Growing Greener grant contract paperwork and participated in 1 meeting with the engineer.

In November 2020, I helped Stream Restoration Inc with beta testing of the new Datashed website.

I am participating in the SW PA Water Network hosted by the Heinz Foundation. In November 2020, I participated in 2 meetings and completed 2 homework assignments. In December 2020, I participated in 1 meeting and completed 1 homework assignment. In January 2021, I participated in 1 meeting with the larger group, 1 meeting with my subcommittee, and 1 meeting with stakeholders to present our work and invite feedback.

#### PA AMR CONFERENCE

#### 2020 PA AMR Conference

The 2020 PA AMR Conference took place virtually on October 28-29, 2020. In November 2020 we held the post-conference wrap-up meeting. I collected PowerPoint presentations for archival. We evaluated the surveys and finalized the bills.
