OUTREACH ACTIVITIES

Blackleggs Creek Watershed Association is interested in applying for a BIL/IIJA AMD/AMD grant for the continuation of the work being done in the watershed. ICCD may be the fiscal sponsor for this application. In May 2024, I continued to organize efforts for ICCD and Blackleggs to submit an application to the PA DEP subrecipient award program. One meeting was held with the consultant to begin work on the application. In May 2024, WPCAMR aided Clearfield County Conservation District in submitting a WCAP application.

The POWR AMD Team, consisting of SRI, EPCAMR and WPCAMR, is contracted by POWR to identify gaps in services and barriers for watershed groups to participate in the BIL/IIJA subrecipient award program. In May 2024, the AMD team met twice, closed out the survey, began analyzing survey results, held two meetings, began planning and scheduling the interview portion of the project, and continued working on the background potion of the report. In June 2024, the AMD team met once, continued analyzing survey results, and conducting the interview portion of the project. I completed 12 interviews. In July 2024, the AMD team met twice, I conducted one additional interview, continued analyzing survey and interview results. I proof read results compilations and I began writing the recommendations section.

WPCAMR is once again partnering to conduct an NTTP AMD Passive Treatment Course with OSMRE and others. In May 2024, I began helping people register for the course and managing the registration list. In June and July 2024, I continued helping people register for the course and managing the registration list.
