#### **OUTREACH ACTIVITIES**

Blackleggs Creek Watershed Association is interested in applying for a BIL/IIJA AMD/AMD grant for the continuation of the work being done in the watershed. ICCD may be the fiscal sponsor for this application. In November 2024, Efforts continued to focus on landowner license agreements. I also worked with DEP regarding a permit that may be required. No news to report.

WPCAMR is administering a WCAP grant for Elk County Conservation District. In February 2025, I completed the semi-annual reports.

WPCMR is administering a WCAP grant for Cambria County CD for Victor 10 pipeline project. In February 2025, the I coordinated with the Cambria CD to make sure they were ready to bid the project and get reimbursements. I also filed the semi-annual report. In April 2025, I coordinated with Cambria County Conservation district on budgeting concerns. There was a site showing to bid out the project.

The POWR AMD Team, consisting of SRI, EPCAMR and WPCAMR, is contracted by POWR to identify gaps in services and barriers for watershed groups to participate in the BIL/IIJA subrecipient award program. In March 2025, the group met twice to discuss possible options for dissemination of the data and recommendations. In April 2025, the group met once to discuss possible options for dissemination of the data and recommendations. Bobby and I met to begin working on our presentation for the Choose Clean Water Conference coming in May 2025.

I had a meeting with the H2O Network to be interviewed about my survey responses for both Blackleggs Creek Watershed Association and WPCAMR.

I had 2 meetings with Keystone Progress Educational Fund regarding their interest in doing a support video for IIJA funded projects.

In April 2025, two AMPs were published, one to advertise for the ARIPPA Award and one to advertise the opening of registration and call for sponsorships for the PA AMR Conference.
