OUTREACH ACTIVITIES

Blackleggs Creek Watershed Association is managing a PA DEP Growing Greener Grant. In August 2023, one meeting was held with the consultant to go over invoices. A reimbursement request was submitted. WPCAMR is administering a WCAP grant for Broad Top Township. In July 2023, the project was completed. In August, the final reports were submitted and the final request for payment was made. In September 2023, I coordinated with Broad Top on getting them their final payment.

I am on the planning committee for the Statewide Watershed Conference, hosted by Pennsylvania Organization for Watersheds and Rivers (POWR) every other year. In August, September and October 2023, one planning committee meeting was held. The conference was held October 29-30, 2023.

WPCAMR partnered with FPW, EPCAMR, BAMR, and OSMRE to host a National Technology Transfer Program Course on AMD. In August 2023, I continued keeping track of registrations and I sent correspondence to attendees. In September 2023, the course was held. I attended one day and drove the bus for the field tour.
